Meeting for Civil law and legal culture, the Summer School will bring together over a hundred students and legal practitioners from all around the world. This event will occur from July 1<sup>st</sup> to July 19<sup>th</sup>, in Paris.

Our ambition is to offer to all participants enrolled a coherent body of courses to convey knowledge on continental law, as well as its evolution and its influence on the legal and economic structures, currently under construction in the world.

The wealth of the Summer School lies in the quality of the education it provides and the diversity of legal cultures represented. We are particularly attached to the international dimension of this event, which makes it a marketplace and crossroad for ideas, legal cultures and knowledge that creates privileged moments of gathering and debate.

# Program description

The courses are available in three different languages: **English, French and Spanish**.

The program offers different courses all taught within the premises of *the University Panthéon-Assas (Paris II)*, by eminent law professors and practitioners, with different fields of expertise and backgrounds.

*One mandatory course:*

➔ **The Civil Law Systems in a comparative perspective**

*Several additional courses (choose 3 courses among the 5):*

➔ **European and international contract law**

➔ **Digital law - Protection of personal data**

➔ **Industrial and intellectual property**

➔ **The Constitutional Courts**

➔ **Settlement of international dispute**

Pursuant to a final examination, participants will be awarded a **certificate of training in Civil Law** by *the University Panthéon-Assas (Paris II)*.

Furthermore, the Foundation for Civil Law organizes meetings with **the paramount French legal actors**, including lawyers, bailiffs and notaries, as well as a cultural program of visits of **the highest French legal institutions** such as the Constitutional Council, the Conseil d'Etat, the Cour de Cassation, the National Assembly and the Senate.

At the end of the three weeks, participants may become members of [the Association of Friends for Civil Law \(A2DC\)](#), and join the alumni's network of the Summer School of Civil law.

## Expected audience

The Summer School targets people (students, legal practitioners, etc.) already graduated with a three-year diploma specialised in law.

The courses are taught in **English, Spanish and French**. Participants need to have a good understanding and use of the language they choose.

# Registration Fees

The registration fees include the classes, conferences, visits and cocktails. For the 2019 edition of the Summer school, the fees are the following:

- 600 € without accomodation
- 1 500 € for the housing / accomodation program for 3 weeks at [the International University Campus in Paris \(CIUP\)](#) .  
The housing in the CIUP is currently limited to the first 50 registered.

Scholarships can be exceptionally granted upon justified request.
